**General Information:**

Summit Clear-Water Barley Straw Extract is a concentrated, natural pond water treatment derived from pure barley straw. This concentrate begins working immediately to clear cloudy water and maintain a unique water environment. Use weekly or as needed to keep your water clear. Our formula contains no chemical additives, only pure barley extract and will not harm plants, fish, or the environment. You can use year-round but best results can be expected when treatment begins in the early spring and continues through the fall.

**Directions for Use:**

Best results are achieved when Barley Straw Extract is used in a preventative manner. After the first application, continue on a two week treatment schedule.

Apply directly into the pond water, preferably where the water is moving into the bulk of the pond. You may increase dose rates up to 50% for incredibly cloudy water.
