APPLICATION DIRECTIONS

Use Restrictions:
This product is not for direct application to plants intended for human consumption (i.e. food plants). Apply only to the perimeter of where food plants are grown to create a repellent barrier. Do not open capsules or disperse contents directly onto plants intended for food use.

Disperse one capsule every 10 to 20 feet around your garden or flowerbed perimeter, ensuring there is a capsule on every outside corner. Do not open capsules or disperse contents directly onto ground.
One capsule application lasts 30-90 Days.
